C.L.O. No. 2272(RG)

12 May 1946

1. An application has been received from the Liquidation Office of the former Government-General of Formosa for delivery of certain official documents.

2. The document in question were delivered on 6 April to the Commission for Japanese Residents, Chinese Government in Formosa, and, after being censored, were handed over on 10 April to the American Forces in Formosa. It is believed that they were then forwarded to the Supreme Commander for the Allied Powers via Shanghai for delivery to the Japanese Government.

3. The documents were packed in 28 packages. They concern the curriculum vitae of the Government-General officials and the transfer of administrative functions to the Chinese authorities, and are urgently needed for the completion of the liquidation of the former Government-General.

4. In view of the nature of the documents, it is requested that the General Headquarters be good enough to deliver them to the Japanese Government on their arrival.
